



## How does a Project get into our CoC's application to HUD?

Must meet Threshold Requirements (All projects)

**Pre-measured Elements** (Renewal projects with at least 1 full year of data)

- Expended grant previously (local requirement if project recpatured, can only apply for 110% of funding spent)
- CoC Scoring Criteria
- Outcomes matter!

### **Community Prioritization**

 Community's perception of the value of the program – members rank bottom 15% and new projects.




### **CoC Application**

- Encompasses everything the CoC does and produces year-round
- Written by STEH & reviewed by the Homeless Clearinghouse
- Scored nationally by HUD in Washington


### **Project Application**

- Information provided by agencies requesting new or renewal grants, in partnership with STEH
- Submitted by STEH
- Must pass a capacity review conducted by the HUD Field Office
- Scored nationally by HUD in Washington



## **CoC System Performance**

- 1. Length of time persons experience homelessness
- The extent to which persons who exit homelessness to PH destinations return to homelessness (recidivism).
- Number of persons experiencing homelessness
- 4. Employment and income growth for persons experiencing homelessness in CoC program-funded projects
- 5. Number of persons who become homeless for the 1st time
- Successful placement from street outreach and successful placement in or retention of permanent housing



## **FY23 NOFO Updates**

The FY23 NOFO has not yet been released, therefore prioritization and application timeline and process are subject to change based on HUD priorities and content of application.

FY23 CoC project year is July 1, 2024 – June 30, 2025

### **Reduction of Points**

Matched to Housed Time reduced from 5 to 3 points

# HUNGER FREE COMMUNITIES RACIAL EQUITY SELF-ASSESSMENT SURVEY

- Must share HFC Self-Assessment Survey Link and Self-Assessment document with everyone in the organization to provide feedback if they choose. Send proof of distribution to NOFAS@end-homelessness.org
- •At least 20 people from each organization/50% of the full organization (within Hamilton Co), whichever is less, should complete the assessment. If agencies choose the latter, must provide total number of employees in Hamilton Co. Based on participation NOT self-assessment score.
- Assessment must be fully completed to receive credit.
- Responses are confidential. Scores are shared but not individual surveys.
- All due by July 18, 2023, at 4PM.

## RACIAL EQUITY AGENCY DEMOGRAPHICS

- The metric is scored by the percentage of staff who self-identify as a race other than white/Caucasian and/or self-identify as Hispanic.
- If an agency cannot provide this information, they do not receive points. Staff who choose not to self-identify should be removed from both numerator and denominator when calculating percentages.
- The organizations will provide staff demographic percentages for the following categories:
  - Non-Supervisor Staff
  - Leadership Staff (Supervisors and above)
  - 3. Board Composition
  - 4. New Hires in the last two years (all positions)

## RACIAL EQUITY AGENCY DEMOGRAPHICS

 Each category of staff/board listed will be scored as defined below with a total of 4 points for this metric.

Percentage of Non-White and/or Hispanic Staff	Points Awarded
<u>&gt;50%</u>	1 point
<u>25-50%</u>	0.5 points
<u>&lt;25%</u>	<u>O points</u>

- How project addresses gap in system/improves the system
- Budget

### **All SSO Projects/KEYS**

- General overview of program
- How program benefits the community
- Data
- CE will present on system gaps

## **Post Event**

- Will be polling attendees to identify in person/virtual/hybrid format for FY24
- Project Application submitted to STEH Fall 2023 (Date TBD)
- CoC Application by STEH to HUD Fall 2023 (Date TBD)
- Award notice from HUD Likely early 2024
- Issues & Conditions Likely Spring 2024
- Match Funding MOUs submitted to STEH Prior to July 1, 2024
